



**NELSON WESTERBERG ACQUIRES CALIF. MOVING AND STORAGE
AGENCY TO EXPAND DOMESTIC NETWORK**

ELK GROVE VILLAGE, Ill. (April 9, 2008) -- Nelson Westerberg, Inc., one of the longest-established global corporate relocation providers in the U.S., recently acquired Lido Van and Storage, an Irvine, Calif. moving and storage company, to expand its domestic operations coast to coast. Lido Van and Storage, founded in 1973, is a trusted single-source provider of transportation and relocation services in the Southern California market.

Nelson Westerberg, family owned since 1904, consistently ranks within the top 250 privately held corporations in Illinois with 2007 consolidated revenue of \$88.9 million. As one of the largest agents in the Atlas Van Lines network, Nelson Westerberg employs 250 people nationwide and 120 professional van operators.

"We've been seeking a California company with the right fit to join Nelson Westerberg," said John Westerberg, Nelson Westerberg CEO. "From within the Atlas Van Lines network we were able to identify a small and financially stable company with similar characteristics as Nelson Westerberg -- family-owned and operated with high standards in customer service and a well-known brand in its home-base market."

The acquisition from Eric Ortiz of Lido Van and Storage as a wholly owned subsidiary of Nelson Westerberg, Inc. was final February 12, 2008. The purchase (sale price undisclosed) adds a key geographic location to Nelson Westerberg's existing domestic network across the U.S. and provides a turn-key operation for the company to compete in California's military and intrastate relocation sectors.

Although Lido Van and Storage is considered a small player in the overall corporate relocation industry, its tenure in the Southern California market adds a valuable brand to the Nelson Westerberg suite of companies. Lido Van and Storage operations include 16,000 sq. ft. of warehouse space, existing and established traffic lanes in the intrastate and military sectors in California as well as professional van operators familiar with the market.

“The acquisition of Lido Van and Storage means business as usual for the Southern California company,” said Westerberg. “We’re pleased that Larry Garcia is staying on as general manager, and his existing staff will also remain. As we continue to perfect our working relationship, Nelson Westerberg will seek to increase our service capabilities in the southern California region.”

Lido Van and Storage has built its brand on intra-state relocation, military and office/industrial moves. It also manages a sizeable portion of COD or individual relocations for families.

“By adding California operations to Nelson Westerberg’s existing regional agencies in Texas, Georgia, Illinois and New Jersey, our customers will benefit from this expansion with a streamlined and seamless hauling capacity featuring Nelson Westerberg coast to coast,” said Westerberg.
